WHEREAS, Chengdu University, SMK Negeri 1 Kragilan Kabupaten Serang and SEAMEO SEAMOLEC have complementary objectives and a mutual desire to collaborate in a number of areas to pursue common educational development. In consideration of the above premises and covenants hereunder provided, both parties to this Memorandum of Understanding (MoU) agree as follows:

1. To collaborate in undertaking programs, projects, and other related activities whenever and wherever feasible opportunities present themselves.
2. To exchange scientific materials, publications, and information.
3. Cooperation in the field of research.
4. Online Collaborative Teaching and learning (Digital Class)
5. To execute separate agreements in writing for any particular undertaking jointly implemented, wherein sharing of responsibilities shall be specified and approved by both parties.
6. Development of Joint courses and education programs
7. To conduct Joint Research, International Seminar, Conference, Symposium and Workshop.

This Memorandum of Understanding takes effect upon signing by the authorized representatives of both institutions, and remains in force for a period of 3 (three) years, subject to amendment at any time by mutual consent. The said agreement shall be extended for an additional period of 3 (three) years at each expiration date, unless either party gives written notice to terminate the agreement at least six months prior to the expiration date.
